AVCA August 2017 Update

AVCA fully endorses Agincourt GO station access and train increase BUT only AFTER the infrastructure - namely safe pedestrian crossings, grade separations and noise mitigation - is complete!

Let's Demonstrate Our Issues

Join AVCA to demonstrate our issues regarding the Minister of Transportation's doubling trains decision and Metrolinx's lack of support for our Community.

<u>Doubling of Metrolinx Trains to 34 Trains per Weekday</u> AVCA is troubled by the following three issues:

1.Increased Safety Anguish

The children in the catchment area for seven schools cross the tracks between Finch Avenue and Sheppard Avenue. AVCA has requested of Metrolinx that safe pedestrian crossings be installed prior to the increase of any trains. The children cross the tracks at grade level in most cases with no pedestrian barrier! Yet the trains increased June 26, 2017!

2. Noise & Diesel Fumes

Metrolinx promised noise walls both sides of the tracks between Old Kennedy Avenue and Sheppard Avenue. Partial installation of the east noise wall has only begun. Increase of trains yields increase of noise in this predominantly residential area! Air Quality from diesel fumes is unhealthy especially with the Metrolinx cutting of our 100 year old tree canopy. Yet the trains increased June 26, 2017!

3. Waste of Taxpayers' Money

On June 26, 2017 - We as taxpayers on Stouffville Corridor have empty trains running between Union and Unionville on one track designed for 1970s freight trains. Presently at Agincourt GO station the 10:04 am- 4:01 pm Metrolinx trains are sparsely utilized and the 7:42 pm-11:16 pm Metrolinx trains are vacant. Why is Metrolinx - a provincial agency - wasting our money by running empty trains?
